

RESOLUTION NO. 140-93

NON UNION SALARY SCHEDULE  
1994

WHEREAS, RCW 36.16.070 states that "...In all cases where the duties of any county office are greater than can be performed by the person elected to fill it, the officer may employ deputies and other necessary employees with the consent of the Board of County Commissioners. The Board shall fix their compensation..."

WHEREAS, RCW 36.40.080 states that "...the Board of County Commissioners shall fix and determine each item of the budget separately and shall by resolution adopt the budget..."

WHEREAS, the fixing of non-union salaries are an integral part of the budgeting process.


NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners does hereby approve:

1) A two and one-half percent (2.5%) increase in salary for all non-union employees for the calendar year 1994, effective January 1, 1994.
